Letter from the President

or 2024, Kentucky REALTORS® has aligned our goals to promote homeownership, availability, and affordability. We have
implemented several strategic initiatives and priorities for the upcoming Legislative Session to help us achieve these goals.

Due to rising interest rates, lack of housing, and several other factors, the American Dream of homeownership has been put further out of reach for many individuals. Wages remain stagnant, and the median sale price continues to climb across the Commonwealth. Our younger generations are crippled with student loan debt, and generational wealth isn't an option for many Kentuckians. In an effort to alleviate many of these issues, we have invested in an Economic Impact Study for the introduction of a First Time Homebuyer Savings Account. If this savings

account is implemented in Kentucky, first-time homebuyers and second-chance homebuyers (those who may have lost a home but have not owned one in the last ten years) would be able to utilize funds in the account for down-payments, closing costs, or any other financial items of the home-buying process.

The ability to choose your REALTOR® is a foundational freedom of the home buying and selling process. Operating in over 30 states (including Kentucky), a real estate brokerage has introduced the 40-year listing agreement; an agreement where a brokerage has the exclusive right to list a property for 40 years. After this agreement with the homeowner is signed, a lien is filed with the County Clerk office. The lien stays with the property, not the individual. Therefore, if the owner passes away or sells the property, the listing agreement would still apply to the future occupant. This brokerage is offering a lump-sum payment ranging from \$300-5,000 to homeowners for the exclusive right to list their property. At any point in time, if the seller decides not to use the brokerage to list the property after signing the agreement, they will be liable for the brokerage's commission. Our Government Affairs Committee and Staff have already taken action to alert our elected officials and government leaders of this issue and provided them with the necessary tools to address it through legislation.

Bringing transparency to a REALTOR[®]'s compensation in the home-buying process is not only a major priority for 2024, but one that all REALTORS[®] need to prioritize in order to educate consumers. There are several lawsuits in the real estate industry, and it is our job to educate our members and consumers to protect our industry and Association. One issue we plan on prioritizing in 2024 is the Buyer-Broker agreement. By requiring all buyers to sign this agreement, we can bring transparency to the compensation process for consumers and REALTORS[®]. KYR staff and leadership will work with the Kentucky Real Estate Commission on ways the Buyer-Broker Agreement can be implemented state-wide through the regulatory process.

In 2024, Kentucky REALTORS[®] will face a number of challenges on the legislative front, but we will face our problems head-on, with as much preparation and clarity as possible. With the help of our members, Kentucky REALTORS[®] will build more bridges and break more barriers than ever before and move our Association onward and upward. Thank you for being a member and for serving our great Commonwealth by providing the American Dream of homeownership to thousands of Kentuckians.

A look ahead at 2024: Inside Frankfort

When one legislative session ends, the prep for the next legislative session begins. Our advocacy efforts never stop. In 2023, the Government Affairs Division within Kentucky REALTORS® (KYR) was led by QRT Chair AnnElizabeth Delahanty and QRT Vice Chair Kelley Nisbet and Government Affairs Chair David Earls and Vice Chair Monti Collins. This Division is and will constantly be in "legislative mode" whether the legislature is in session or in the interim period.

The interim period, the time between legislative sessions, is designated for a more in-depth look at policy matters to determine what legislation may be necessary for the 2024 Regular Session, a 60-day budget session scheduled to begin next January. The primary focus of the 2024 session will be crafting the next biennial state budget and road plan.

With the budget in mind, the Government Affairs Division has its sights set on a few items that we will be following closely:

Tax Reform

Tax reform was passed during the 2022 legislative session that added additional services to Sales Tax. Even though real estate services continue to be exempt, KYR needs to continue to monitor and discuss how the new tax structure – removal of the income tax – will impact REALTORS.

Economic and Community Development

Housing and economic development should go together. When new jobs are being recruited to Kentucky, housing must be part of that discussion. Kentucky is already seeing a shortage in residential homes.

First-Time Home Buyer Savings Program



40-Year Listing Agreement

Property owners enter into a service agreement in exchange for upfront cash without expressly knowing they will be required to use the company's listing services in the future for upwards of 40 years. The property owner agrees by signing a memorandum that is filed with the county acting as a lien on the property. The contract is binding for current homeowners and property heirs. KYR sees this business practice as major a consumer protection issue.

KREC

The primary responsibility of the Kentucky Real Estate Authority (KREA)/Kentucky Real Estate Commission (KREC) is to protect the consumer by regulating the real estate licensees in Kentucky. Kentucky REALTORS[®] is concerned with how the KREA/KREC is currently resourced to protect the consumer. Additional staffing is needed to help with regulatory enforcement and licensing requests.






